- 4. The Executive Council of IMU in its 59th meeting vide reference 3<sup>rd</sup> cited has approved to implement the proposal from the Academic year 2021-22 for admission to all the UG and PG Programmes of IMU as given below: -

Certificate Category	Incentive / Bonus Marks
C Certificate	5% of the maximum marks of the examination
B Certificate	3% of the maximum marks of the examination
A Certificate	2% of the maximum marks of the examination

- 5. IMU is pleased to inform that the Bonus Marks for NCC A, B and C certificate holders for admission into all UG/PG programmes will come into effect from the Academic Year 2021-22 onwards.
